Residential Rezoning and Wildlife Preservation



Part I Demographic Information

Question #	Description	Response	Percentage
1	Own	132	99%
2a	Full Time Resident	128	96%
2b	Part-time resident	5	4%
3a	Small Household	103	77%
3b	Medium Household	27	20%
3c	Large Household	4	3%

- 96% of TVV homeowners have small to medium households; while just,
- 4% are part-time residents



Part II- Residential Rezoning

Question#	Description	Percentage
1	Interest in annexations/rezonings	96%
2	Understand annexation/rezoning processes	46%
3	Aware of rezoning activities	90%
4	Have protested rezoning	90%
5	Have supported rezoning	7%
6	TVV needs more rentals	8%
7	TVV needs more owner-occupied	45%
8	Opposed to increased density	91%
9	Opposed to higher density near main roads or commercial sites	70%

- 92% of respondents are opposed to increased density and rezoning in TVV; while just,
- 46% understand the formal annexation/rezoning processes; and,
- 7.5% of respondents believe TVV needs more rentals and support rezoning to achieve this

Part II- Residential Rezoning

Question #	Description	Percentage
10a	Higher density unacceptable due to-traffic increase	85%
10b	Higher density unacceptable due to environmental damage	86%
10c	Higher density unacceptable due to flooding damage	85%
10d	Higher density unacceptable due to stress on schools	57%
10e	Higher density unacceptable due to stress on infrastructure	77%
11a	Increase housing density beneficial to provide need	13%
11b	Increase housing density beneficial to draw commercial business	12%
11 c	Increase housing density beneficial to increase social connections	14%

- 78% of respondents believe that higher density developments in TVV are unacceptable
- Categorically, respondents believe that higher density developments in TVV are unacceptable for various reasons.



Part III- Wildlife Preservation

Question #	Description	Percentage
1	Concerned with decreasing wildlife and bird environment in TVV	94%
2	Concern that TVV wildlife threaten residents, pets, etc.?	9%
3a	Like more nature conservancy groups	84%
3b	Like more horse property	69%
3c	Like more trails for hiking, birding, biking, horseback riding	88%
3d	Like larger lots/acreage, more space	84%
4	Should TVVA seek to engage with more Tucson wildlife orgs?	83%

 84% of respondents are concerned about the wildlife in TVVA and prefer more environmental and recreational opportunities as well as engagement with conservancy groups.
